Dear RPRC Committee,

We are planning to remove our in ground oil tank(waiting for permit) and replace with an above ground oil tank. There are very large roots sticking up in the path of the delivery route. We would like to remove the roots to prevent any tripping, etc. If we only remove the roots, the tree will suffer, become weak, and may fall on our neighbor's home(12 Nichols Road). The tree sits on the property line between our homes. To prevent this we would like to remove the entire tree and the roots. It is a maple, about 36" in diameter and 50' tall. It is also enrobed in poison ivy. On Friday April 9, Building Inspector Ivan Quintero was at our home for an unrelated inspection and we showed him the tree. He took a picture to add to our file.

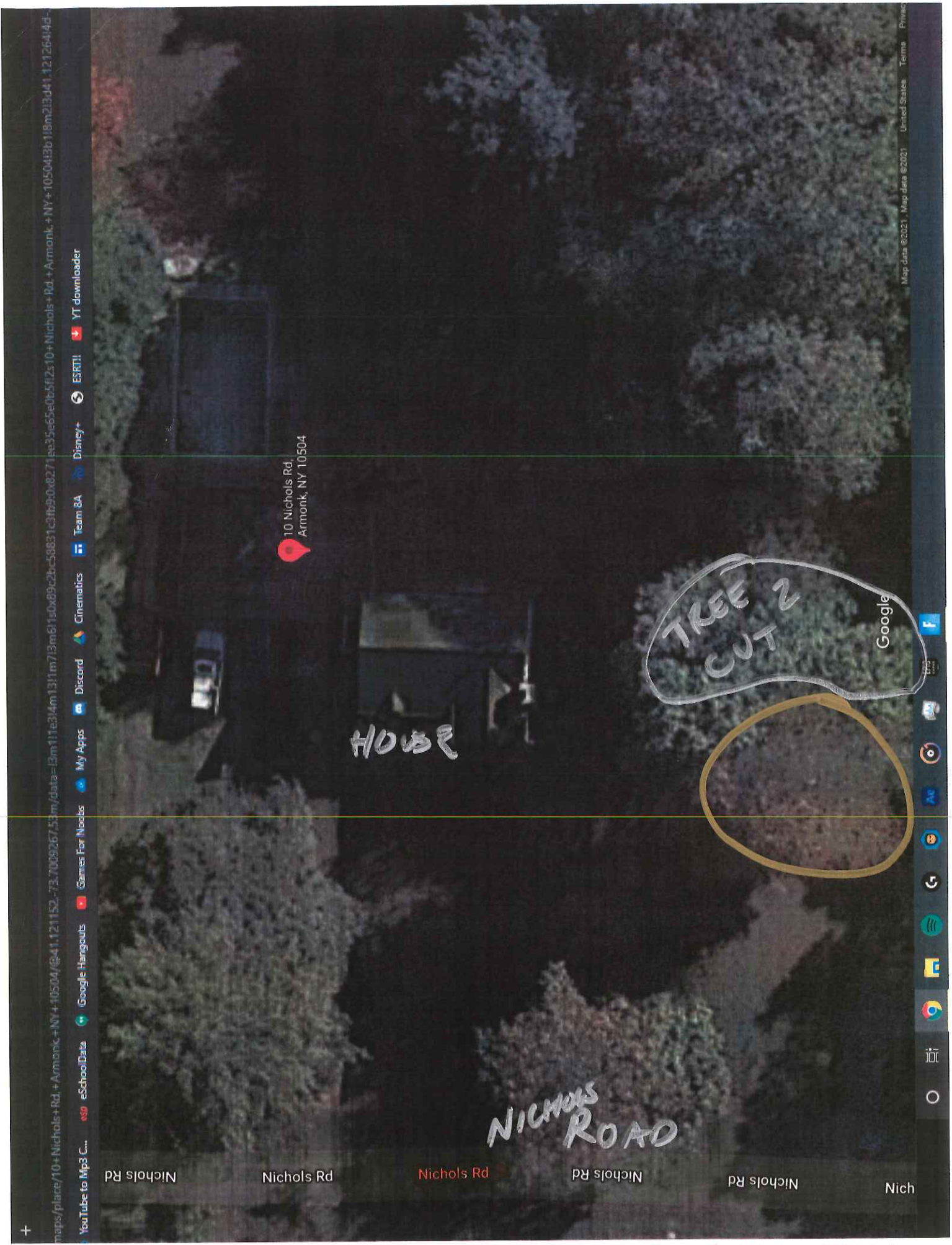

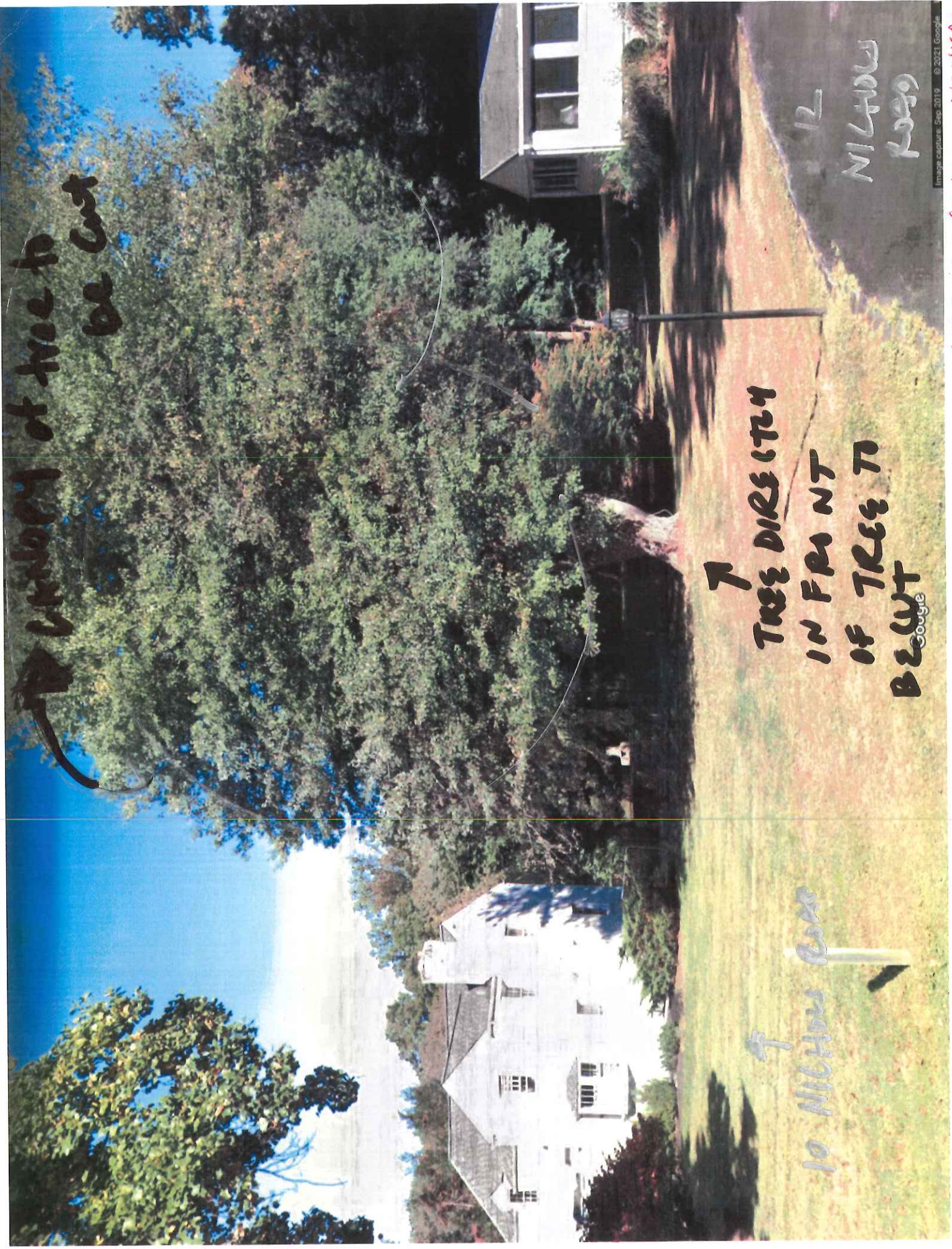

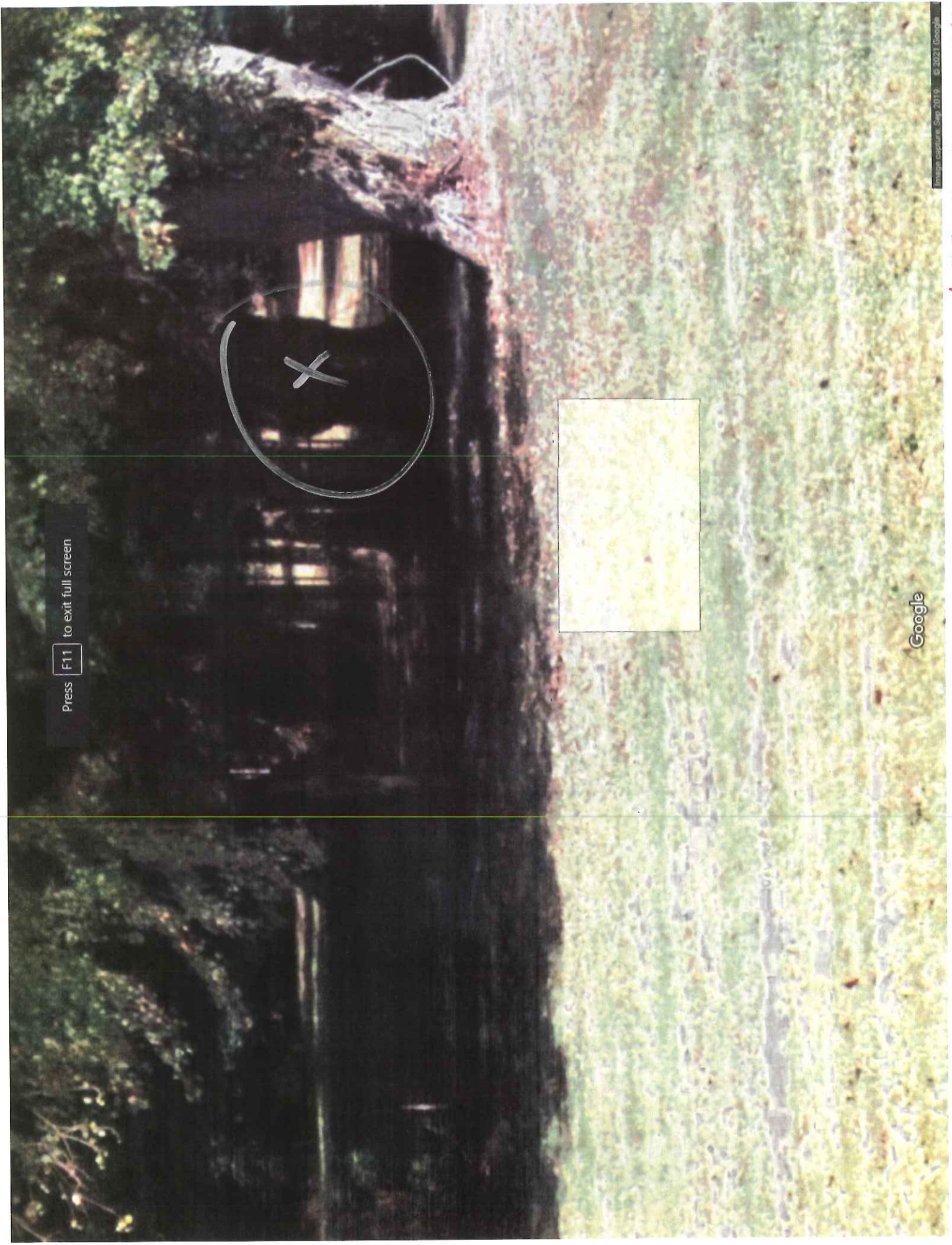


Canopy of tree to be cut

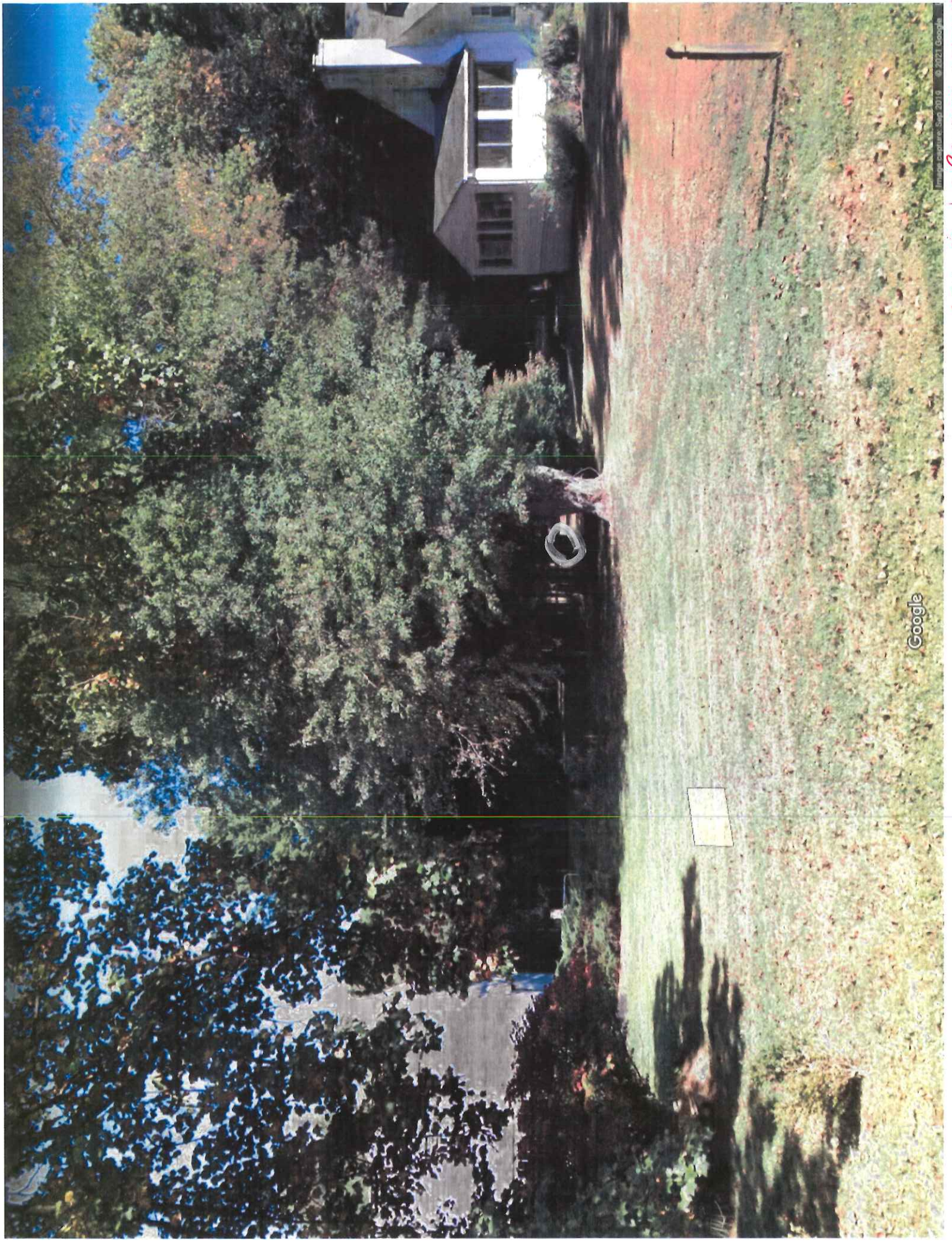
