Description of Action: The Applicant is seeking approval of a proposed lot line realignment that would alter the existing common lot line in the area of the former Old Whippoorwill Road by transferring 3,317 s.f. from 82 Whippoorwill to 84 Whippoorwill. The transfer will result in 82 Whippoorwill decreasing in size from 0.948 to 0.872 acres and 84 Whippoorwill increasing in size from 0.490 to 0.566 acres
