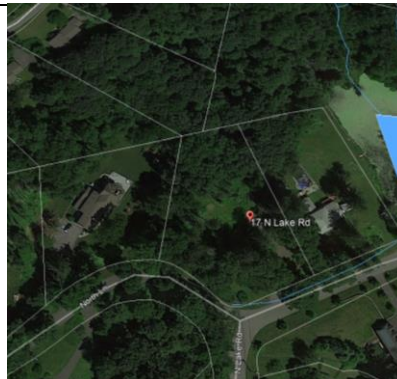

**BRIEF SUMMARY OF REQUEST**

Construction of a new two-story, single family dwelling with municipal water supply and on-site wastewater treatment system along with pool and driveway.

This project was referred to the Planning Board by the Residential Project Review Committee.

**PROPERTY HISTORY**

**COMPATIBILITY with the COMPREHENSIVE PLAN**

- Continue to take neighborhood context into account in approving new single-family homes.
- Continue to protect natural resources and environmentally sensitive areas such as rivers, streams, lakes, ponds, wetlands, flood plains, aquifers, wildlife habitats, steep slopes and forested areas, significant trees, and woodlands, among others, from unnecessary and avoidable impacts.
- Continue strong protection of tree cover through the tree removal permitting process.
- Preserve the current overall development pattern of North Castle and its neighborhoods. Be sure new development responds to environmental constraints, particularly for preservation of the New York City watershed.
- Maintain the quality-of-life created by physical and natural attributes, by structuring development that promotes sound conservation measures.
- The Town should encourage residential development that is compatible in scale, density, and character with its neighborhood and natural environment.

**STAFF RECOMMENDATIONS & PLANNING BOARD POLICY DECISIONS**

1. The Planning Board should direct the Applicant to address the comments contained in this memo and resubmit to the Planning Board for further discussion.

<p><u>Procedural Comments</u></p> <ol style="list-style-type: none"> <li>1. The Proposed Action would be classified as a Type II Action pursuant to the State Environmental Quality Review Act (SEQRA).</li> <li>2. A neighbor notification meeting regarding the proposed amendment will need to be scheduled.</li> <li>3. Pursuant to Section 12-18.A of the Town Code, all site development plans submitted to the Planning Board are required to be referred to the Architectural Review Board (ARB) for review and comment.</li> </ol>	<p><u>Staff Notes</u></p> <p>Construction, expansion or placement of minor accessory/appurtenant residential structures, including garages, carports, patios, decks, swimming pools, tennis courts, satellite dishes, fences, barns, storage sheds or other buildings not changing land use or density.</p>
<p><u>General Comments</u></p> <ol style="list-style-type: none"> <li>1. The submitted plans are essentially the same plans originally submitted to the Planning Board. At the November 9, 2020 Planning Board meeting, the Planning Board directed the Applicant to address the issues raised in the Planning Department and Town Engineer memos. Of particular concern is the amount of proposed tree removal, amount of disturbance, lack of revegetation/screening, lack of screening for the property to the east and distance between the house and proposed pool complex.</li> <li>2. The submitted demolition plan depicts the removal of 27 Town-regulated trees.</li> <li>3. The pool is proposed a significant distance from the house in a location that is heavily treed. It is recommended that the Applicant study an alternative location that minimizes Town-regulated tree removal and that is located closer to the proposed home.</li> <li>4. The Applicant should submit a landscaping plan that provides screening between the subject lot and adjacent properties. Particular attention should be given to screening between 10 and 19 N. Lake.</li> <li>5. The Applicant should submit gross floor area and gross land coverage calculations worksheets for review. In addition, a backup floor area exhibit should also be submitted for review.</li> <li>6. The Applicant should identify building height (average grade to roof midpoint) and maximum exterior wall height (lowest grade to roof midpoint) on the submitted elevations.</li> <li>7. The site plan should be revised to include a zoning conformance table.</li> </ol>	<p>Pursuant to Section 308-15.A(11) of the Town Code, the Applicant should prepare a replacement tree plan to mitigate the impacts from the proposed tree removal.</p> <p>In the October 20, 2020 response memo, the Applicant stated that The pool's location has been chosen due to the pitch required for discharge and due to the proposed primary septic area, see Engineers "Proposed Site Plan."</p> <p>In the R-1A Zoning District, maximum building height is 30 feet and maximum exterior wall height is 36 feet.</p>
