Section 1. Amend Section 355-23 of the Town Code to add Warehouse use as a permitted principal use in the IND-AA Zoning District (New King Street):

10. Warehouses, excluding truck storage or truck terminal facilities.

Section 2. Conflicting Standards.

Where the requirements of this Local Law impose a different restriction or requirement than imposed by other sections of the Code of the Town of North Castle, the Town Law of the State of New York or other applicable rules or regulations, the requirements of this Local Law shall prevail.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any other part of this local law that can be given effect without such invalid part or parts.
