# ATTACHMENT TO NEGATIVE DECLARATION REASONS SUPPORTING DETERMINATION

The Planning Board cites the following reasons supporting this Negative Declaration:

The Proposed Action will not have a significant adverse environmental impact as a result of any physical change to the project site.

The project will result in limited physical changes to the site. Specifically, an 18" berm is proposed to provide enhanced protection to the adjacent wetland and a new gravel area for stormwater mitigation. The Planning Board has determined that the physical impacts are small to moderate in nature.

#### The Proposed Action will not have a significant adverse environmental impact on any CEA.

The project will result in limited physical changes to the site. Specifically, an 18" berm is proposed to provide enhanced protection to the adjacent wetland and a new gravel area for stormwater mitigation. The Planning Board has determined that the physical impacts on the Mianus River CEA are small to moderate in nature.

### The Proposed Action will not have a significant adverse environmental impact on any unique or unusual land forms.

The project will result in limited physical changes to the site. Specifically, an 18" berm is proposed to provide enhanced protection to the adjacent wetland and a new gravel area for stormwater mitigation. The Planning Board has determined that impacts to water bodies are small to moderate in nature.

# The Proposed Action will not have a significant adverse environmental impact on surface or groundwater quality or quantity.

The project will result in limited physical changes to the site. Specifically, an 18" berm is proposed to provide enhanced protection to the adjacent wetland and a new gravel area for stormwater mitigation. The Planning Board has determined that impacts to surface or groundwater quality or quantity are small to moderate in nature.

# The Proposed Action will not have a significant adverse environmental impact on or alter drainage flow or patterns, or surface water runoff.

The Planning Board has determined that the flood impacts are small in nature and that the flood impacts will be adequately mitigated via the floodplain development permit process or LOMA process.

The Proposed Action will not have a significant adverse environmental impact on air quality.
