A Notice of Complete Application was received for Water District #4 and a copy sent to James Daloia on the duly adopted motion of Councilman Geist.

Councilman van Leeuwen moved, seconded by Councilman Geist, the following Solid Waste Emergency Resolution:

WHEREAS, the Town of New Castle, the Town of Bedford, the Town of North Castle and the Town of Somers (hereinafter, collectively the "Consortium" or the "Towns") are parties to a Municipal Cooperation Agreement dated as of June 27, 1987, pursuant to which, among other things, the Towns agreed to purchase, acquire and make available to themselves certain solid waste disposal services, including the acceptance of the nonhazardous waste materials generated and collected within the Towns at a transfer station for processing and the transportation of such waste from the transfer station to a solid waste management facility for final disposal (hereinafter, the "Solid Waste Services"), and authorized and directed the Town of Bedford, as Agent, to purchase and acquire such Services and to enter into an agreement for same on behalf of the Consortium; and

WHEREAS, the Consortium solicited bids for the Solid Waste Services and awarded the contract for such Services to Karta Container & Recycling, Inc. (hereinafter "Karta"), the lowest responsible bidder, in accordance with General Municipal Law Section 103 (1); and

WHEREAS, on July 12, 1989 the Consortium entered into a Recycling and Waste Management Agreement (hereinafter, the "Agreement") with Karta whereby Karta would perform the Solid Waste Services for a three (3) year term commencing on September 1, 1989, subject to an option by the Towns to extend the term of said Agreement for two (2) successive one (1) year periods; and

WHEREAS, the Agreement provides that Karta shall provide a recycling and waste transfer station (the "Transfer Station") located at 1011 Lower South Street, Peekskill, New York for the collection of the
